A Home with Deep Roots

Kevin and Carol's home is steeped in history. The home was originally bought by Harold Cosgrove, a WWII veteran, in the mid-1950s. His harrowing war story began during the Battle of the Bulge where he was captured by the Germans. He narrowly survived enslavement inside a Nazi concentration camp and was released by the British on April 28, 1945, weighing only 75 lbs. He lived the remainder of his life on Laurel Lane. The house has seen generations of Kevin's family, as his stepfather Kenny Cosgrove's childhood home and where his sister Jennifer Santacroce-Wheeler raised her first two children. The neighborhood is a close-knit community where everyone knows each other, and block parties with music and potlucks are common.

Family Heritage

Kevin's family has deep roots in the area. His father, Peter Santacroce, is an avid record collector who grew up in Sag Harbor. Kevin's mother, Donna Demai Cosgrove, now retired, owned Rocking Horse preschool for 17 years in East Hampton. She later worked at Rainbow Preschool. Her ancestry goes back 12 generations in East Hampton/Amagansett. Kevin's stepfather, Kenny Cosgrove, employed by JCP Landscaping, is connected to many in the area, including their neighbor and cousin, Dave Cosgrove. Kenny's ancestry goes back 12 generations via his mother Judith Miller Cosgrove. As Sag Harbor locals, his parents worked at the Bulova Watchcase factory and Rowe Industries. Kevin's sister, Jennifer Santacroce-Wheeler, is a lifelong horse trainer, and her husband, David Wheeler, owns the construction company, DKW Home Improvements.

Kevin and Carol have shared many adventures, including a honeymoon in Japan during Sakura, the spring cherry blossom festival. They have also traveled to Alaska, Majorca, the Dominican Republic, and recently, Charleston, South Carolina. Before their marriage, they road-tripped across the United States, visiting New
